The following time bands are presently available to customers wishing to connect to the Super Economy 12 tariff which provides for a normal and a low unit price option:

**Time Band 101
(Low Rate Times)**

20:00 – 06:00 (8.00pm – 6.00am)
12:45 – 14:45 (12.45pm – 2.45pm)

**Time Band 129
(Low Rate Times)**

22:07 – 08:07 (10.07pm – 8.07am)
14:35 – 16:35 (2.35pm – 4.35pm)

In all cases we will make every effort to ensure that you are selected for the time band that you request. However, should this not be possible due to network loading restrictions you will be connected to the closest alternative time band. **Unfortunately, time bands cannot be changed once selected.**

For connection to Super Economy 12 tariff additional space may be required at the meter position for the extra equipment required. Any connections are for a minimum of 12 months.

Please note that for customers planning to install **Additional Load**, a separate application procedure is required.
